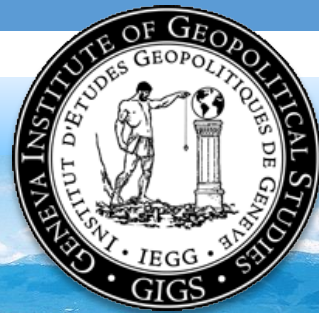

Why Study Geopolitical Analysis and Strategic Foresight?

Contemporary international relations are characterized by an increasing complexity. The difficulty of apprehending the epoch in which we live in is due, among other factors, to the enlarged number of actors, rapid technological advances, resource competition, global power shift, identity conflicts, and the tensions caused by the contradictory processes of globalization. As a result of this increased complexity, the capacity to carry out geopolitical analysis to examine the interactions between geographic, demographic, economic, cultural, cognitive and strategic factors, alongside their relevant impacts on tensions, conflicts, trends and foreign policy decisions, becomes more relevant than ever in a wide variety of professional fields.

Strategic foresight is the projection of a current situation into the future. It is rather impossible to precisely tell what shall happen in the future; however, different scenarios can be elaborated on as regards the possible impending evolutions of a given geopolitical condition. The objective of the strategic foresight in geopolitical analysis is to anticipate different situations that may occur to support decision making processes on different levels, ranging from political, economic, and diplomatic to military.

MAIN OBJECTIVES

The main objectives of this study program are to introduce the main components of the geopolitical analysis method and present the key elements of strategic foresight and geopolitical risk assessment. The course adopts an interdisciplinary approach that incorporates strategic, geographic, historic, cultural, cognitive and economic dimensions to decipher the complexity of contemporary international relations. The central themes include the concepts and method of geopolitical analysis, cognitive factors and geopolitical representations, as well as the application of strategic analysis, geopolitical risk assessment, strategic foresight, and geopolitical scenario building. Case illustrations are presented on various geopolitical configurations that significantly impact the current world system. Having completed this study program, participants are expected to demonstrate the ability to apply the geopolitical analysis method in different case study situations and to integrate geopolitical factors and foresight in decision making processes.

LECTURERS

Mr. Gyula CSURGAI obtained his Doctorate from the University of Geneva. His doctorate research focused on the development of the geopolitical analysis method and its application in different case study situations. He holds Degrees in Political Science from the University of Concordia (Canada) and the University of Toulouse (France). Dr. Csurgai earned Postgraduate Degrees in European Studies from the European Institute at University of Geneva and from the department of Philosophy from the same university. Dr. Csurgai has taught geopolitics, geoeconomics, strategy, international relations, and diplomacy for undergraduate, masters, and doctorate programs at different universities in Switzerland and in other countries. He has participated in several international research projects and has provided expertise to various international organizations, governments, and private corporations. Dr. Csurgai is co-founder of the Geneva Institute of Geopolitical Studies. He published several books and articles in the fields of geopolitics, geoeconomics, economic intelligence, and international relations.

Mr. Alexandre LAMBERT holds a Ph.D. in International Relations from the Graduate Institute of International and Development Studies in Geneva. He served as lead researcher on the Organization for Security and Co-operation in Europe (OSCE) at the Graduate Institute, as a project officer at the Geneva Centre for the Democratic Control of Armed Forces (DCAF), and as a civil servant at the Swiss Federal Department of Defence. He also provides independent policy advice to the OSCE Forum for Security Co-operation (FSC), including in connection with its regional activities in the Western Balkans, the South Caucasus, and Central Asia. Dr. Lambert is the author of several books and articles in the fields of international relations, geopolitics, and international security. His current research focuses primarily on the geopolitics of Eurasia and the Belt and Road Initiative. He has taught International Security, Foreign Policy, and Geopolitics for several years at universities in Switzerland and abroad. He currently serves as Academic Director of the Geneva Institute of Geopolitical Studies.
